<u>Project Brief of Nominated Sub-contract for Soft Landscape Works for Project KC-008(A) at Chun Tin Street/Sung Chi Street, Kowloon City</u>

1. Project Background

The project at Chun Tin Street/Sung Chi Street, Kowloon City ("Project") is being developed by the Authority with a total gross floor area ("GFA") of about 13,860m² and comprises the following:

- 1.1 One residential tower with 260 residential units and residential recreational facilities on 3/F and 36/F with a total domestic GFA of about 12.270m²:
- 1.2 3-storey podium consisting of commercial areas with a total non-domestic GFA of about 1,590m²; and
- 1.3 2-storey basement carpark.

2. Scope of the Sub-contract Works

The scope of the Sub-contract Works generally includes the following:

- 2.1 Supply and laying topsoil mix, soil conditioners, mulch and fertilizer to planting areas;
- 2.2 Supply and planting of ground cover plants, shrubs, trees, etc;
- 2.3 Supply and installing irrigation system and associated pipework;
- 2.4 Supply and fixing sub-soil drain layers inside planters; and
