**葉迪奇太平紳士**

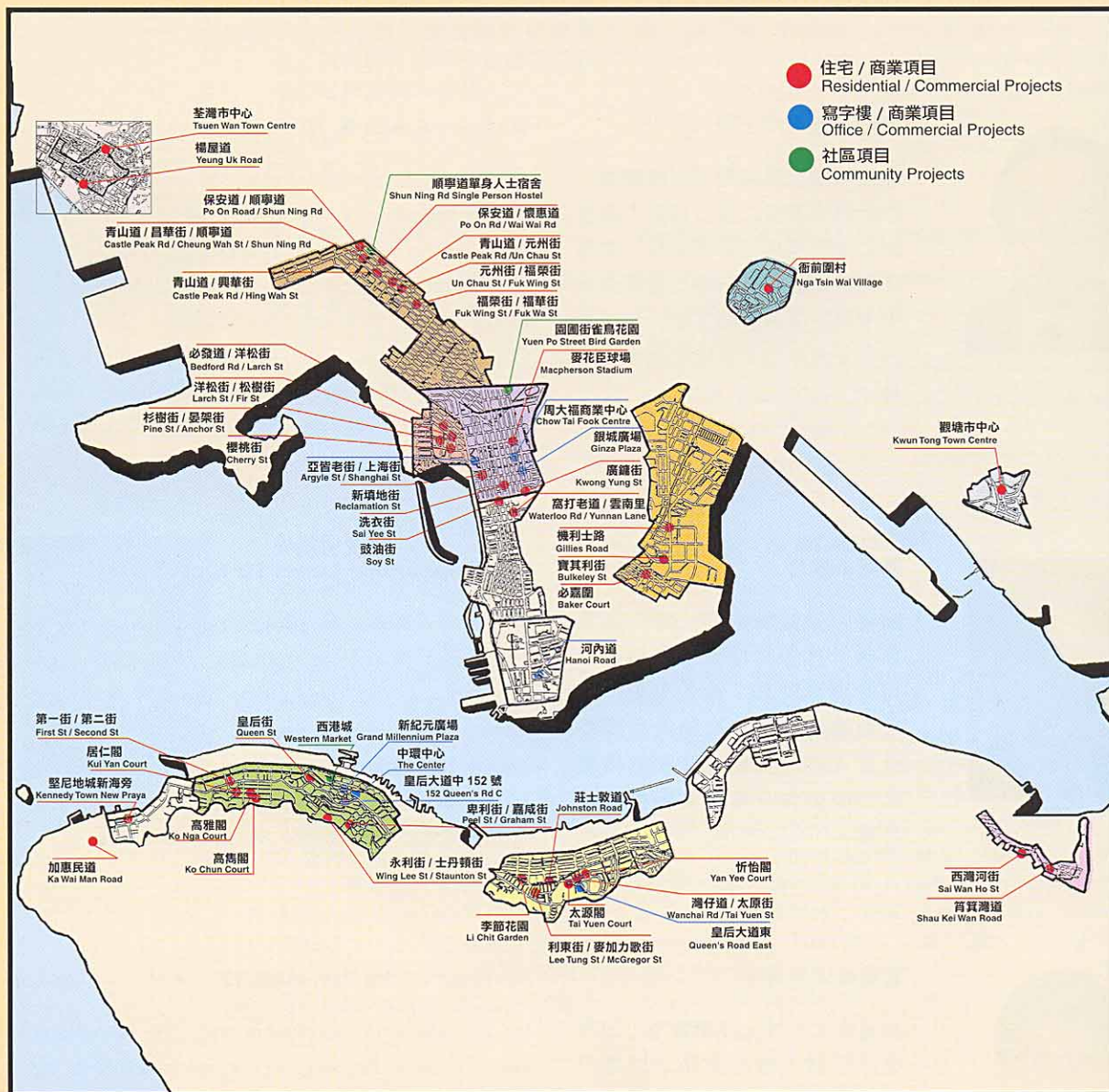
